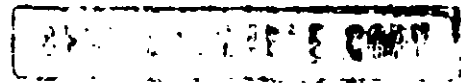

Statement of Practical Treatment

If Swallowed: Immediately contact a physician or poison control center. Contains petroleum distillates. Do not induce vomiting due to aspiration hazard. **If Inhaled:** Remove person to fresh air. Contact a physician if needed. Apply artificial respiration if indicated. **If On Skin:** Remove affected clothing and wash skin with plenty of soap and water. Contact a physician if irritation persists. Wash clothing before reuse. **If In Eyes:** Flush with plenty of water. Contact a physician if irritation persists. **NOTE TO PHYSICIAN:** Solvent may present aspiration hazard. Gastric lavage may be indicated if product was taken internally. Propoxur and Dichlorovos are organophosphate insecticides. If symptoms of cholinesterase inhibition are present, atropine sulfate by injection is antidotal. 2-PAM is also antidotal and may be administered but only in conjunction with atropine.

Physical or Chemical Hazards

Contents under pressure. Do not use or store near heat or open flame. Do not puncture or incinerate container. Exposure to temperatures above 130° may cause bursting.
