

Wait 48 hours before removing the nest. Hose off with water any bliage of desirable plants contacted during spraying.

For the control of ants and spiders (only outdoors): For ants and spiders found in areas such as electric service baxes, water meter boxes, telephone boxes, along house foundation, foundation vents, sills and ledges, etc., spray in short bursts to contact pests. Ant trails, runways and hills should also be sprayed as necessary. Do not spray foliage of desirable plants. If spray does contact foliage, hose off with water.
