COCKROACHES, PALMETTO BUGS, EARWIGS, SOWBUGS, CENTIPEDES, MILLIPEDES, CRICKETS, SILVERFISH, AND CLOVERMITES: Spray thoroughly into hiding places such as cracks, crevices, moist areas, and openings around pipes, spigots, storage areas, and sheds. Spray directly on insects when possible. Repeat treatment if necessary.
