What to expect

Discoloration and blackening of moss within a few days, with full effect of this treatment in 3 to 4 weeks.

If lawn remains thin, a reinfestation of moss is likely. To maintain a good barrier against moss, regular fertilization of all turfgrasses and selective pruning of tree branches in shaded areas are recommended to promote growth of dense turf.

A temporary darkened appearance of the lawn for up to 2 weeks may result after application of this product.

How and when to apply

Apply curing winter or spring (December through April) when ross is actively growing.

Directions for use

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

TO CONTROL MOSS IN LAWNS:

- It is best to apply when the lawn is moist and tall grass has been mowed to expose low-growing moss. Sprinkle granules over mossy areas in lawn. Use diagram as a guide for application rate.
- Vigorous raking of the moss-infected area prior to treatment will enchance moss control.
- Do not apply to a newly seeded or sodded lawn until it has been mowed four times.
- Keep product off sidewalks, patios, driveways, etc.
 Brush particles off concrete, stone, clothing, or shoes
 immediately to prevent staining. This product will
 stain. (Iron stains on concrete can be effectively
 removed with products containing phosphoric acid, such
 as Naval Jelly. Products containing oxalic acid can
 effectively remove iron stains from clothing. Follow
 package directions to obtain best results.)

 Allow one week between the application of this product and other control products. (This guideline can be relaxed where severe insect or disease attack requires immediate treatment.)

TO CONTROL MOSS AROUND FLOWERS AND ORNAMENTAL SHRUBS:

- Apply anytime moss is actively growing. Sprinkle granules over mossy areas. (See diagram for application rate.)
- · Wait several days and carefully rake out dead moss.
- IMPORTANT: Moss-Eraser™ will burn foliage if applied directly to plants. If contact occurs, wash material off plants immediately.
