

For use in the control of exposed stages of roaches, silverfish, ants, flies, mosquitoes, flying moths, waterbugs and spiders.

**DIRECTIONS**

DILUTE D-P-L CONCENTRATE at the rate of 1 quart to 19 quarts of Deodorized Kerosene for the uses shown below. Spray infested areas only until wet.

**ROACHES, SILVERFISH, ANTS, WATERBUGS AND SPIDERS:**

Treat thoroughly infested areas such as cracks, baseboards, behind shelving, stoves and refrigerators, beneath sinks and cabinets, around water pipes and other hiding places.

Repeat as necessary.
