WARNING

ENVIRONMENTAL HAZARDS

This product is toxic to fish, birds, and other wildlife. Use with care when applying in areas adjacent to any body of water. Keep out of lakes, streams, ponds, tidal marshes and estuaries. Shrimp and crabs may be killed at application rates recommended on this label. Do not apply when weather conditions favor drift from target area.

This pesticide is highly toxic to bees exposed to direct treatment or to residues remaining on the treated area. Do not apply when bees are actively visiting the crop, cover crop, or weeds blooming in the treated area.
