Apply every 5 to 10 days as required for control. Apply with 100 gallons of water with each application. Add fungicide to water before combining it with any insecticide or spreader-sticker.

SUGAR BEETS: For Cercospora leaf spot.

Apply at the rate of 1½ to 2 lbs. per acre in 100 cal. water. Begin application before disease affects plant growth. Apply every 7 to 10 days as required for control. Do not apply within 14 days of harvest. Add fungicide to water before combining it with any insecticide or spreader-sticker.
