TO KILL POTATO VINES: Apply undiluted sulfuric acid (93%) at a rate of 17-28 gallons per acre per application. Apply at least five (5) days prior to harvest to allow tubers to mature. Repeat after five (5) days if vines are not completely desiccated. Do not harvest within five (5) days of application.

Do not apply this product in a way that will contact workers or other persons, either directly or through drift. Only protected handlers may be in the area during application. For any requirements specific to your State or Tribe, consult the agency responsible for pesticide regulation.

AGRICULTURAL USB REQUIREMENTS

Use this product only in accordance with its labeling and with the Worker Protection Standard, 40 CFR part 170. This Standard contains requirements for the protection of agricultural workers on farms, forests, nurseries, and greenhouses, and handlers of agricultural pesticides.
