- 2. The protective clothing and cleaning up instructions must be placed under the Precautionary Statements section.
- 3. Delete the sentence, "Do not apply directly to water or wetlands (swamps, bogs, marshes, and potholes)." from the Environmental Hazards section. Replace the deleted sentence with, "Do not apply directly to water, or to areas where surface water is present or to intertidal areas below the mean high water mark."
