Dear Ms. Harding:

The following amendment submitted in connection with registration under FIFRA, as amended, is acceptable with the conditions listed below.

#### **Proposed Amendment**

- Revise Basic and Alternate Formulation
- Revise Storage and Disposal Statements per PR Notice 2007-4
- Revised First Aid Statements

### Conditions

Revise label as follows:

1.) Delete the term, "Powerful" from the claim "Contains Powerful Fungicide and Insecticide," on pages 1 and 2 because it is heighten efficacy (PR Notice 93-6).

2.) Delete the term, CAUTION, because it is a signal word used on other pesticide products. The use of this term is confusing to the users.

3.) The 6<sup>th</sup> statement under "Wood in Contact with Soil or Water" on page 2 must be brought into compliance with PR Notice 2000-5, Mandatory Labeling by deleting the term, should, and stating "*must*."

4) The 5 <sup>th</sup> statement under Option 1 and 2 and the 11 <sup>th</sup> statement under Option 2 on page 3 must							
be brought into compliance by deleting the term, recommended. The fifth statement under Option

1 and 2 must read "When no finish is to be used, *apply two generous coats within 1 hour, or a 3 minute dip.* Revise the 11<sup>th</sup> statement under Option 2 to read "Do not overcoat with latex...."

5.) The Copper RED required the addition of Personal Protective Equipment (PPE) to be added to the label based on occupational exposure concerns. Therefore, you must revise the "Precautionary Statements" by adding the following information:

## Personal Protective Equipment (PPE)

Applicators must wear the following:

- long-sleeve shirt

- long pants

chemical resistant footwear plus socks

chemical resistant gloves made of waterproof material

Some materials that are chemical resistant to this product are rubber, neoprene, or nitrile. If you want more options, follow the instructions for category A on an EPA chemical resistant category selection chart.

### **User Safety Instructions**

Users must wash hands before eating, drinking, chewing gum, using tobacco, or using the toilet.

Users must remove clothing/PPE immediately if pesticide gets inside. Then wash thoroughly and put on clean clothing. After handling product, immediately remove PPE and wash thoroughly as soon as possible and put on clean clothing. Wash the outside of gloves before removing.

This product is toxic to fish and aquatic invertebrates and may contaminate water through runoff. This product has the potential for runoff for several months or more after application. Poorly draining soils and soils with shallow water tables are more prone to produce runoff that contains this product. Runoff may be hazardous to aquatic organisms in water adjacent to treated areas.

The Confidential Statements of Formula for the basic and alternate formulations dated November 20, 2009 is acceptable. It is in compliance with PR Notice 91-2 and in agreement with the label.
