The following directions are furnished by us and are believed to be reliable but in no way guaranteed. Make first application when insects appear or disease threatens and repeat weekly if necessary. Consult your State Agricultural Experiment Station or Extension Service for specific timing and dosage rates in your area.

BEANS: To control Mexican Bean Beetles, Downy Mildew and Rust, apply 25 to 30 lbs. per acre. Do not apply after pods begin to form. Do not feed treated threshings to livestock.

BROCCOLL CABBAGE AND CAULIFLOWER: To control Cabbage Looper, Imported Cabbage Worm, Diamond-back Moth Larvae, Alternaria Leaf Spot and Downy Mildew. Do not apply on cauliflower after edible parts begin to form and do not apply to broccoli or cabbage within 7 days of harvest. Apply 20 to 25 lbs. per acre.

CUMCUMBERS, MELONS AND SQUASH: To control Aphids, Anthracnose and Downy Mildew apply 25 to 30 lbs. per acre. Apply as needed up to harvest.

HEAD LETTUCE: To control Aphids, Cabbage Looper, Imported Cabbage Worm, Diamond-back Moth La. vae and Downy Mildew apply 25 to 33 lbs. per acre. Do not make more than 3 applications after thinning. Do not apply within 14 days of harvest. Remove outside leaves at harvest. Do not feed crop refuse to livestock.

PEPPERS AND TOMATOES: To control Aphids, Colorado Potato Beetle, Flea Beetles, Anthracnose and Early and Late Blight apply 15 to 20 lbs. per acre. Do not apply within 4 days of harvest. When applying in greenhouse, wear a mask or respirator passed by the U.S. Bureau of Mines for Thiodan protection. To avoid damage, do not use on tender, young greenhouse plants.

POTATOES: To control Aphid; Colorado Potato Beetle, Flea Beetles, Leafhoppers and Early and Late Blight apply 30 to 35 lbs. per acre. Apply as needed up to harvest. Do not plant root crops other than carrots, potatoes or sweet potatoes as followup crops.
