CAUTION

Avoid contact with eyes, skin and clothing. Avoid breathing vapors or spray mist. Do not allow spray to contact food, feedstuffs, and water supplies. Thoroughly wash dishes and food handling utensils with soap and water if they become contaminated by application of this product. Do not use in poultry houses or other animal buildings. Remove pets and cover fish bowls (tanks) before spraying. Wash thoroughly after handling.

STATEMENT OF PRACTICAL TREATMENT

If Swallowed: Drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. Do not give anything by mouth to an unconscious person. Get medical attention.

If on Skin: In case of contact, remove contaminated clothing and immediately wash skin with plenty of soap and water.

If in Eyes: Flush eyes with plenty of water.

NOTE TO PHYSICIAN: Chlorpyrifos is a cholinesterase inhibitor. Treat symptomatically. Atropine only by injection is an antidote.

Do Not Use or Store Near Heat or Open Flame. Do Not Store Below 32 Degrees F.

ENVIRONMENTAL HAZARDS

This product is highly toxic to bees exposed to direct treatment or residues on plants. Protective information may be obtained from your Cooperative Agricultural Extension Service.

This product is toxic to fish, birds, and other wildlife. Keep out of lakes, streams, ponds, tidal marshes, and estuaries. Shrimp and crabs may be killed at application rates recommended on this label. Do not apply where these are important resources. Do not apply where runoff is likely to occur. DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

General Information: Use this product to control the pests indicated in the areas listed below by application as an undiluted spray (0.5% Chlorpyrifos). Repeat the treatment as needed.

Do not apply sprays of this product in conduits, motor housings, junction and switch boxes or other electrical equipment because of possible shock hazard. Do not allow children or pets to contact treated surfaces until spray has dried.

NOTE: Successful flea & tick control must include not only thorough spot treatment of the areas in and around the home, but also treatment of the infested animal. This can best be done either with an approved insecticide for use on pets or by a veterinarian. At the same time this is being done, and prior to chemical treatment of the premises, there are a few tips that will aid in the success of controlling your flea or tick problem.

- Vacuum the entire house thoroughly. Pay particular attention to vacuuming under furniture, in areas where pets sleep or rest, in cracks and crevices along walls, and all upholstered furniture.
- The vacuum bag contents should be destroyed or discarded outside, to get rid of all the accumulated flea larvae and pupae.
- Pet bedding should be destroyed or washed thoroughly in hot water, and replaced with clean, fresh bedding after treatment.

FOR CONTROL OF FLEAS AND BROWN DOG TICKS:

Indoor - Thoroughly apply as a spray for spot treatment to infested areas such as pet beds and resting quarters; nearby cracks and crevices; along and behind baseboards, window and door frames and localized areas of floor and floor covering where these pests may be present. **DO NOT TREAT PETS WITH THIS PRODUCT.**

Outdoor - Apply undiluted Arab Flea & Tick as a spray in outdoor areas where there are weeds or brushy non-crop areas in and around kennels, animal runs or under porches where pets may rest. Spray these infested areas thoroughly. Repeat application as infestations warrant and as reinfestations occur.

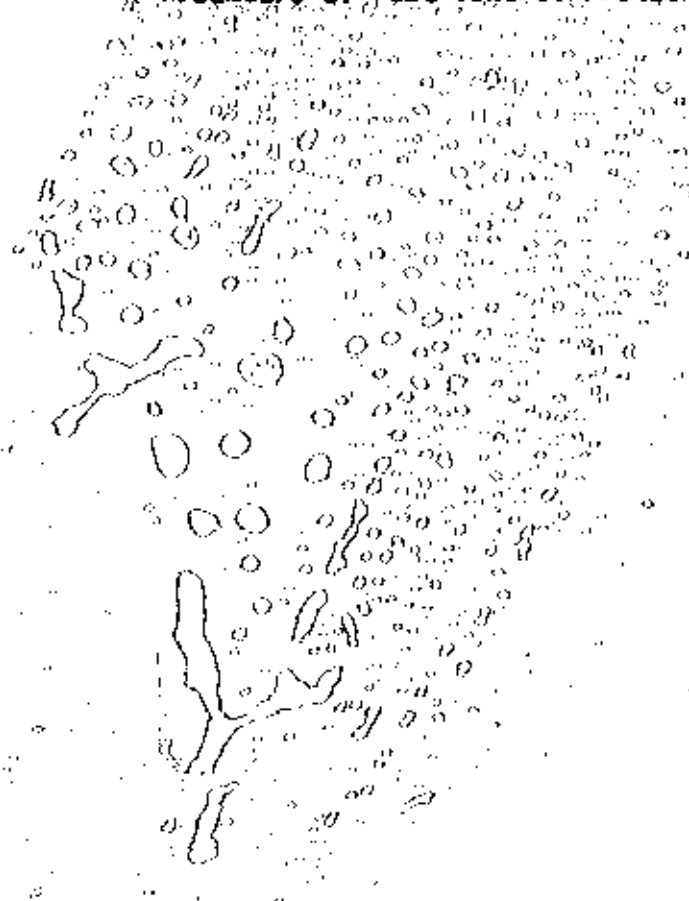
