

DIRECTIONS FOR USE

Do not spray on Plants.

TO KILL FLYING INSECTS

Indoors: Close doors and windows and spray into air with circular sweeping motion. Keep three feet from walls. Remove birds and fish from room before spraying. A 5 to 6 second spray is sufficient to kill flies, mosquitoes and wasps in an ordinary 1000 cubic foot room or office. Repeat as necessary.

Do not remain in treated areas. Ventilate the area after treatment is completed.

Outdoors or Open Areas: The number of flies, mosquitoes and wasps can be reduced by misting or fogging surroundings when air is quiet. Repeat as necessary.

TO KILL CRAWLING INSECTS TITAN' Supreme is effective against ants, roaches, waterbugs and palmetto bugs. Spray into hiding places such as cracks and crevices, under baseboards, under sinks, in closets and cracks in floors.

Spray ant trails and areas where ants enter, such as around window and door frames. Spray surface until wet.
