DESTROYS

HOUSE FLIES, MOSQUITOES, BED BUGS, SMALL FLYING MOTHS, FLEAS, WATER BUGS, ROACHES, FLIES, AND GNATS.

FOR HOUSEHOLD USE:

INDOORS: Close doors and windows. Direct OFLYO spray toward ceiling. Room should be filled with mist and remain closed for ten to twenty minutes. Sweep up and destroy fallen insects. Repeat treatment as often as necessary.

OUTDOORS: For temporary control, spray porches, patios and other places where there are insects. Repeat as necessary.

ROACHES, WATER BUGS AND SILVER FISH.

Spray OFLYO liberally with force around refrigerators, sinks, cabinets, pantry shelves, into cracks and crevices, in moulding and woodwork, pipe openings in walls and floors or wherever insects are likely to hide. Repeat treatment as often as necessary.

ANTS

Spray OFLYO so as to wet as many insects as possible, paying particular attention to nests or runways. Repeat treatment as often as necessary.

BED BUGS

Dismantle bed and spray with OFLYO, springs and mattresses, paying particular attention to cracks, crevices, tufts and seams of mattresses, loose wall paper, loose moulding and places where these insects may hide. Repeat spraying with OFLYO weekly, since bed bugs are difficult to kill.

SMALL FLYING MOTHS

Take special precautions that floor cracks and openings below baseboards are thoroughly wetted with OFLYO spray. Wool, lint or organic matter accumulating in these places serve as breeding materials for insects. Clothing to be stored should be cleaned, aired and sprayed carefully with OFLYO from a distance of one to two feet; see that seams and folds are wetted with the spray. Chests in which woollens are stored should be thoroughly sprayed before being filled with clothes. Closets should be sprayed liberally at least twice a month; direct spray on the garments. Repeat as necessary.

FLEAS

Spray thoroughly sleeping quarters and bedding of pets and allow to dry thoroughly. Spray areas including furniture frequented by pets. Spray floors, rugs and lower walls of basement and rooms. Repeat as needed. Do not spray animals.

Where used in enclosed spaces, do not remain in treated areas.

Ventilate the area after treatment is completed.

ENVIRONMENTAL CAUTIONS: This product is toxic to fish. Keep out of lakes or ponds. Do not contaminate water by cleaning of equipment or disposal of wastes.

Apply this product only as specified on this label.

Do not re-use container. Destroy by perforating or crushing and discard in a safe place.
