

## 15-7-7 WITH INSECT CONTROL

ACCEPTED

For the control of turf pests such as Japanese Beetle Grubs, Wireworms, Mole Crickets, Ants and Sod Webworms.

## HOW TO USE

For the control of turf insects on large turf areas such as golf courses, estates, parks, athletic fields, etc., apply at the rate of 300 lbs. (225 lbs. Technical Heptachlor) per acre. For small applications, apply at the rate of 10 lbs. per 1,000 sq. ft.

An economical, effective and convenient means of controlling insects, and feeding turf in one operation, apply with a fertilizer spreader to insure even distribution.

For control of Japanese Beetle Grubs, June Beetle Grubs, Wireworms, Mole Crickets and Ants: Apply either in early spring or fall (except when ground is frozen) when turf is dry. Then water thoroughly to wash material into the root zone, or apply just before a rain. One application may control pests for several years.

For control of Sod Webworms: When damage is apparent, apply when turf is dry and water lightly.

Use only for recommended purposes and at recommended rates.
