Use suitable ground or air equipment to insure good coverage. Apply when pests appear in damaging numbers and repeat 7 to 14 days later if necessary.

CORN — Use 10 to 13 pounds of BALCOM SEVIN 15% GRANULES per acre for first generation European corn borer larvae in whorls. Do not apply within 7 days of harvest.

Consult your state agricultural experiment station for proper timing of treatments.

When used according to label directions, corn, including forage, may be grazed or harvested for use as feed for dairy or meat animals.
