Lebanon Uniform 10-6-4 with 2,4-D Weed and Feed

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable with the following provisions:

1) Revise the first two sentences of the Precautionary Statements to read as follows:

"Harmful if swallowed, absorbed through skin or inhaled. Causes eye irritation. Avoid contact with skin, eyes or clothing. Avoid breathing dust."

2) Rewrite the Statement of Practical Treatment to read as follows:

"IF SWALLOWED: Call a physician or Poison Control Center. Drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. If person is unconscious, do not give anything by mouth and do not induce vomiting."

"IF IN EYES: Flush eyes with plenty of water. Call a physician if irritation persists."

"IF ON SKIN: Wash with plenty of soap and water. Get medical attention."

"IF INHALED: Remove victim to fresh air. If not breathing, give artificial respiration, preferably mouth-to-mouth. Get medical attention."

- 4) Add a statement to follow the recommended spreader settings to read "NOTE: Above spreader settings are approximate. Check your spreader on 100 square feet and adjust to apply only 6 ounces per 100 square feet."

#### DIRECTIONS

This product is a mixture of 2,4-D and fertilizer for application to active growing broadleaf weeds. Better results are obtained if applied when ground moisture is adequate. During dry weather, water lawn thoroughly 24 hours prior to application. For persistent weeds, or if a heavy rain within 2 days after application, a second application may be necessary. The maximum number of broadcast applications per treatment site is two per year.

Sweep all fertilizer materials from concrete surfaces immediately after application. Do not wash materials from concrete surfaces because some fertilizers may contain iron which may cause discoloration upon oxidation.

#### FOR ESTABLISHED LAWNS:

With a calibrated spreader, apply evenly at a rate of 4 lbs. per 1,000 sq. ft. Do not apply to creeping grass such as bentgrass. Do not mow, water or make heavy use of lawn for at least 24 hours after spreading.

#### **FOR NEW LAWNS:**

Do not apply to newly-seeded lawns until after 2nd or 3rd mowing.

#### STORAGE AND DISPOSAL

**STORAGE:** Keep in original container in a cool, dry area, away from extreme heat and direct sunlight. Do not store near food, feed, seeds or other pesticides.
