

DIRECTIONS

LACCO LIN-O-MULSION 1.7 is prepared for use against certain pests of crops as listed below. Dosages are given in pints of this product per acre in sufficient water to provide uniform coverage. This product is highly toxic to bees exposed to direct treatment or residues on crops. Protective information may be obtained from you Co-operative Agricultural Extension Service.

CUCURBITS (Melons and Squash): Aphids, cucumber beetles, melon and pickle worms, leaf miners and thrips. Spray when insects first appear. Apply 1 to 2 pints per acre. Repeat when needed. Do not apply to squash within 1 day of harvest.

COLE CROPS (Broccoli, Cabbage and Cauliflower): Aphids and thrip. Spray when insects first appear. Apply 2 to 3 pints per acre. Repeat when needed. Do not apply after the edible parts start to form.

ONIONS: Thrips, spray when insects first appear. Apply 1 to 2 pints per acre. Repeat when needed. Do not apply to green or spring onions.

FLOWER CROPS: Aphids, lace bugs, thrips, ants, leafhoppers, grasshoppers and diamond backed moth larva, spray when insects first appear. Apply 1 to 2 pints per acre. Repeat when needed. Avoid spraying open flowers.

PINE TREES: Western pine beetles, California flathead borer, Jeffrey pine beetles, Fir engraver beetle, for a 1.25% emulsion, apply 6½ gallons of LACCO LIN-O-MULSION 1.7 per 100 gallons of water. Spray to the point of runoff. Repeat at 6 month intervals until controlled.

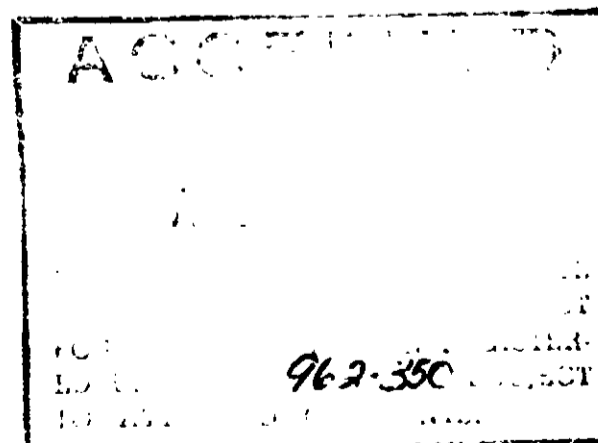
