DIRECTIONS
FOR MANUFACTURING USE ONLY

To 50 parts by weight of PYROCIDE PRESSURIZED SPRAY MIX 5927 add 10 parts isopropyl alcohol and 40 parts propellant 12. Pack in a pressurized container.
