# CATEGORY OF APPLICATOR

Certified applicators or pursues under their direct supervision.

# STORAGE AND DISPOSAL

Do not use on mature crops or in any case for 15 days before harvest. Do not use on meture crops or in any case for 15 days before harvest. Do not apply to cucurbits before the plants start to vine or when plants are wet. Wash all fruits and vegetables before marketing or using.
