The comments below pertain to the label was submitted for this product on November 16, 2010, and received on the same date.

1. In the "Azaleas and Camellias:" paragraph under "ORNAMENTALS" (page 7), the first sentence may be broken into the two sentences shown below.

To control Scale Insects, Spider Mites, and Whiteflies, use one gallon of product per 100 gallons of water. Apply in spring after blooming and in fall prior to blooming and at least 3 weeks before the first anticipated freeze.

- 2. In the "STORAGE AND DISPOSAL" box (page 8), the subheading "STORAGE:" should be changed to "PESTICIDE STORAGE:".
- 3. In the second sentence of the second paragraph under "WARRANTY DISCLAIMER AND LIMITATION OF LIABILITY" (page 9), "factory" should be changed to "factors".

The applicator must compensate for this displacement at the downwind edge of the application area by adjusting the path of the aircraft upwind. Leave at least one untreated swath at the downwind edge of the treated field.

CHEMIGATION PROHIBITION

Do not apply this product through any type of irrigation system.

CITRUS - Grapefruit, Lemons, Limes, Oranges, Tangelos, and Tangerines. Do not exceed a maximum of 159 pounds of active ingredient (in a maximum volume of 1500 gallons of spray mix per acre) when treating citrus in Florida and Texas or a maximum of 212 pounds of active ingredient per acre (in a maximum of 2000 gallons of spray mix per acre) when treating citrus in California, based on thorough coverage spray, with 1.5 gallons of product per 100 gallons of water.

Apples, Pears, Peaches, Cherries, Plums, and Grapes:

Use 1/2 cup to one gallon of water (1.5 gal./50 gal. of water) to control European Red Mite eggs, green apple aphids, rosy apple aphids, black peach aphids, green peach aphids, black cherry aphids, grapevine aphids, San Jose scale, white peach scale, Terrapin scale, and European Fruit Lecanium. Spray thoroughly, wetting insects on both sides of leaves.

Oaks, Elm, Willows, and Basswood (Linden):

Use at same strength as for fruit trees. Do not use on Maple, Mountain Ash (*Sorbus*), or Beech trees.

Avocados:

Avocado Red Mites - use 3 quarts of product per 100 gallons of water.

Florida Red Scales, Avocado Whitefly, and Pyriform Scales - use one gallon per 100 gallons of water. Apply when infestations first appear.

Precautions for Ornamentals:

Do not use more than one gallon per 100 gallons of spray as injury may possibly result under certain circumstances. Do not use oil sprays on foliage within 30 days before or after using sulfur or Captan. Do not spray broadleaved evergreens when temperatures are near or below freezing.
