NYLAR®, a unique ingredient in this flea spray, continues to kill fleas for 120 days (4 months) by preventing their development into the adult biting stage. It reaches fleas hidden in carpets, rugs, drapes, upholstery, pet bedding and floor cracks. Protects your home from reinfestation and flea buildup, and your pets and family from bites. One treatment with this spray gives continuous flea protection for 120 days. Leaves no objectionable odor or sticky mess and, used as directed, does not stain furnishings.

FLEAS & TICKS: SHAKE WELL. Hold can 2 or 3 feet from surfaces to be treated. Be sure to apply uniformly using a sweeping motion to carpets, rugs, drapes and all surfaces of upholstered furniture.
