DIRECTIONS FOR USE

Fill the spray tank approximately 1/2 full of water and with the agitator running add the required amount of this spray mix. Keep the agitator running until spraying has been completed.

CITRUS: (Florida only): Mix entire contents (21 lbs.) with 500 gallons. For control of scab, melanose, and to supply maintenance nutritional requirement of zinc, manganese, and boron.

Dormant: Against scab apply just before flush appears, usually late January or early February.

Post Bloom: Against scab and melanose apply one to two weeks after petal fall.
