DIRECTIONS

SEWAGE LINE APPLICATION: Connect and install drum with a 24 hour continuous drip system containing a 10% solution. Allow this solution to drip into sewer from highest point in sewer line.

SEWER UPKEEP, STREET CULVERTS, GARBAGE, WASTE AND DUMP AREAS, STORM DRAINS, GUTTERS, SLUDGE BEDS, PITS, REFUSE AND DISPOSAL GROUNDS: To keep these areas free from sulfurous gases, odors, slime, etc., spray area daily with a 1% to 2% water solution.

GREASE TRAPS: This CONCENTRATE deodorizes and dissolves grease and scum formations which cause clogging of drains. By the daily pouring of a solution of 4 oz. of CONCENTRATE, in a quart of water, into grease traps, serious stoppages can be avoided.

HEAVY GREASES, TARS AND OILS: This CONCENTRATE will remove heavy greases, tars and oils from machinery, tools, metal parts and garage floors. Spray or paint onto surface to be cleaned. Allow a few minutes for foreign matter to loosen then remove by flushing with water or steam jennie.
