POISON

ANTIDOTE: If swallowed: Give a tablespoonful of salt in a glass of warm water and repeat until vomit fluid is clear. Have victim lie down and keep quiet. Call a physician immediately. If on skin: In case of contact remove contaminated clothing and immediately wash skin with soap and water.

NOTE TO PHYSICIAN: In case of poisoning, give atropine, preferably by injection, grains 1/30 to 1/15 (2 to 4 mg) at once and every hour or oftener as needed to achieve and maintain full atropinization. Never give Morphine. Clear chest by postural drainage. Artificial respiration or oxygen administration may be necessary. Observe patient continually for 48 hours.

KEEP OUT OF REACH OF CHILDREN (12 Pt. Type)

Poisonous if swallowed, inhaled or absorbed through skin. Do not get in eyes, on skin or on clothing. Wear natural rubber gloves, protective clothing and goggles. In case of contact, wash immediately with soap and water. Wear a mask or respirator of a type passed by the U. S. Department of Agriculture for parathion protection. Keep all unprotected persons out of operating areas or vicinity where there may be danger of drift. Vacated areas should not be re-entered until drifting insecticide and volatile residues have dissipated. Do not contaminate feed and foodstuffs. Wash hands, arms and face thoroughly with soap and water before eating or smoking. Wash all contaminated clothing with soap and hot water before reuse.

DIRECTIONS FOR USE

This dust is prepared specifically for aircraft application to apple trees to control apple scab, apple mites, European saw fly, bud moth and red-banded leaf roller. Apply at the rate of 20 lbs. per acre. Begin applications at the pre-pink stage and continue prior to apple scab infections during the pink, calyx and cover applications. Do not use this dust within 21 days of harvest.

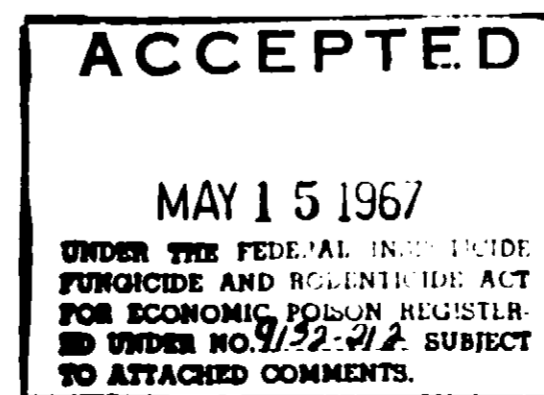
