The Registration Division (RD) has conducted a review of this request for its applicability under PRN 98-10 and finds that the action requested falls within the scope of PRN 98-10.

The alternate brand names "Hartz UltraGuard Plus Flea & Tick Carpet Powder Clean Fresh Scent" and "Hartz InControl Flea & Tick Carpet Powder Clean Fresh Scent" have been added to the product record.

The label submitted with the application has been stamped "Notification" and will be placed in our records.
