For best results, entire dwelling should be treated (with particular attention to kitchens and bathrooms). Use one fogger for each 16,000 cubic feet (or 1,600 square feet).

1. Close outside doors and windows and turn off fans and air conditioners. Open interior doors, cupboards and closets of areas to be treated.
2. Extend, wish open flames except pilot lights.
3. Remove pets, but be sure to leave pet bedding as this is a primary hiding place for fleas and must be treated to get best results. No need to discard pet bedding after treatment.
4. Cover or remove fish tanks and bowls. Cover or remove exposed food, dishes, utensils, food handling equipment and plastic items such as eye glasses, stereo covers, and electronic items. Do not use in commercial food processing or storage areas. Have rugs, bases, slip covers, upholstered furniture in place. Used as directed this product will not harm them, just the fleas highly irritate.
5. Place fogger on a raised area such as a table or chair with newspapers covering the area directly under the can.
6. Keeping at arm's length, point top of can away from face and press down actuator bar to lock in position and start fogging action. Set in an upright position and leave treated area for 10 hours.
7. After 2 hours, open all doors and windows, turn on air conditioners and fans, and let the treated areas air for 10 hours.
8. All food processing surfaces should be covered during treatment or thoroughly cleaned before using.

STORAGE & DISPOSAL

If page - Store in cool area away from children. Disposal - Replace cap. Wrap in paper in layers of newspaper and dispose in trash. Do not incinerate or puncture.
