DIRECTIONS FOR USE

MYSTOX LPL - 4E is a weather resistant fungistat containing 4.0% fatty acid esters of pentachlorophenol for textile industry applications. This fungistat does not discolor cellulosic fabrics and is resistant to leaching. Fabrics treated with the recommended levels of MYSTOX LPL - 4E will survive extended soil burial without appreciable loss of tensile strength, and will control mold and mildew organisms so often associated with spotting and staining of fabrics. This product is for use on non-clothing fabrics only.

MYSTOX LPL - 4E is an emulsion system and should be applied as received. Conventional padding equipment may be used after which the fabric can be dried on cans or on a frame. Small items may be dried in ovens or hung in ventilated areas until dry.

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.
