

OUTDOOR FOGGER KILLS UP TO 20 FEET AWAY

It is preferable to spray when air is calm. If breeze is light, if light breeze is blowing spray with the breeze NOT into it.

Kills and repels mosquitoes, flies, gnats, wasps, hornets, flying moths, ants, crickets and centipedes.

INSTRUCTIONS: Shake before using. Be sure nozzle is pointed away from face. Spray area while tilting container slightly toward ground area.

FOR FLYING INSECTS: Such as mosquitoes, flies, gnats, wasps, hornets, and flying moths. Spray with a waving motion of arm so that mist will drift over larger area. Spray bushes and ground cover from a distance no closer than 4 to 6 feet. Pay special attention to breeding areas. Repeat if needed.

FOR CRAWLING INSECTS: Such as ants, crickets and centipedes. Spray ground or patio areas needing treatment, hitting as many insects as possible. Also spray table and chair legs. Spray into holes for best results.

CAUTION

Not for indoor use. Flammable mixture. Do not use or store near heat or open flame. Do not smoke while spraying. Cover any exposed food. Do not spray toward face. Avoid inhalation of vapors. Be careful not to spray on food, clothes or household pets. Spray no closer than 4 to 6 feet from ornamental plants. Do not spray over fish ponds. Avoid contact with the skin. Do not let children handle. Contents under pressure. Do not puncture. Exposure to heat, including direct exposure to sunlight, may cause bursting. Do not discard in fire or incinerator.





