NUBARK MANCOZEB AS is a fungicide designed for the dry treatment of potato seed pieces to suppress Fusarium, Rhizoctonia, and Black Leg. Thoroughly dust whole or cut potato seed pieces with NUBARK MANCOZEB AS at the rate of 1 lb. of Nubark Mancozeb AS per 100 lbs. of seed pieces. Apply the treatment so that the cut seed pieces are thoroughly covered with dust by the use of a convenient container or dust attachment over the belt. Do not exceed the label rate.

Thoroughly clean and sanitize cutting machines, knives, trays, tables, barrels, equipment, trucks and planters before cutting and planting seed pieces. If seed potatoes have not sprouted, subject them to temperatures between 50 to 60 degrees F for approximately 10 to 15 days before handling. Treat the warmed seed pieces immediately after they are cut. Seed pieces should be planted immediately after treatment. If cut and treated seed pieces cannot be planted immediately, they should be held for a minimum of one week at cool temperatures and high relative humidity, prior to planting. This holding period promotes suberization and allows the cut surfaces to heal.

This product contains the antibiotic, streptomycin. To reduce the development of drug-resistant bacteria and maintain the effectiveness of this and other antibacterial products, this product should be used only to treat or prevent infections that are proven or strongly suspected to be caused by bacteria.

This material is not to be used for medical or veterinary purposes.

Language required for bags containing treated seed-pieces:

Seed-pieces that have been treated with this product that are then packaged or bagged for future use must contain the following labeling on the outside of the seed/seed-piece package or bag:

"Treated Seed/Seed-Pieces - Do not use for Food, Feed, or Oil Purposes.

When opening this bag or loading/pouring the treated seed/seed-pieces that are treated with the fungicides, mancozeb and streptomycin sulfate, wear long-sleeved shirt, long pants, shoes, socks, chemical resistant gloves, and a NIOSH-approved respirator with a dust/mist filter with MSHA/NIOSH approval number prefix TC-21C or any N, R, P, or HE filter.

After the seeds/seed-pieces have been planted, do not enter or allow worker entry into treated areas during the restrictedentry interval (REI) of 24 hours. **Exception:** Once the seed/seed-piece are planted in soil or other planting media, the Worker Protection Standard allows workers to enter the treated area without restriction if there will be no worker contact with the soil/media subsurface."

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.
