
The amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended to update your label, is acceptable provided that you make the labeling changes listed below before you release the product for shipment bearing the amended labeling.

- 1. In the ingredients statement change the "Inert Ingredient" from 90% to 80%.
- Revise the Environmental Hazards to read as follows: 2.

"This pesticide is toxic to fish and aquatic organisms. Do not discharge effluent containing this product into lakes, streams, ponds, estuaries, oceans or public waters unless in accordance with the requirements of a National Pollutant Discharge Elimination System (NPDES) permit and the permitting authority has been notified in writing prior to discharge. Do not discharge effluent containing this product to sewer systems without previously notifying the sewage treatment plant For guidance, contact your State Water authority. Board or Regional Office of the EPA".

Revise the Precautionary Statements to read as follows: 3.

If Swallowed: Drink large quantities of water. alcohol. Call a physician immediately. If in Eyes: Flush with plenty of water for at least 15 minutes. Consult a physician if irritation occurs. If on Skin: Wash thoroughly with soap and water. Remove contaminated clothing before reuse. Get medical attention if irritation persists.

4. Revise the Storage and Disposal to read as follows:

Do not contaminate water, food, or feed by storage or disposal.

Storage: Do not stack more than four drums high. Leaking or damaged drums should be placed in overpack drums for disposal. Spills should be absorbed in sawdust or sand and disposed of in a sanitary landfill. Keep container closed when not in use.

Pesticide Disposal. Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

Container Disposal:

Plastic: Triple rinse (or equivalent). Then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, by incineration, or if allowed by state and local authorities, by burning. If burned, stay out of smoke.

For maximum effectiveness, pools containing heavy growth of algae, should be cleaned prior to using this product. For pools having visible growth of algae, add an initial dose of 20 to 30 oz. per 5,000 gal. water and remove settled algae debris by cleaning (vacuuming). For treatment of freshly cleaned and filled pools, add initial dose 12.5 to 20 oz. per 5,000 gal. pool water. To maintain pools free of visible algae growth, subsequent additions of 5 oz. per 5,000 gal every 5-7 days after initial treatment. Uniform distribution is necessary. Pour this product all around pool and throughout the pool water for maximum effectiveness.

This product is compatible with those chemicals normally used to treat pools and is effective at both acid and alkaline pH. This product can be used in pools treated with chlorine chemicals and may reduce the amount of those chemicals normally required. However, do not mix this product with concentrated dry or liquid chlorine products.
