

Then adjust and maintain the pH in the range of 7.2 to 7.6. Use Coastal pH Plus or pH Minus as indicated by a PoolChem Test Kit. Follow label directions for these products. Then superchlorinate with Blast One Shot Shock Treatment or Iso Cior Super Stabilized Chlorinating Powder to establish a free chlorine residual of 1.0 to 1.5 ppm (parts per million).
