The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable. This approval does not affect any conditions that were previously imposed on this registration. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. Pursuant to 40 CFR 156.10(a)(6) you must submit one copy of the final printed labeling before you release the product for shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 18 months from the date of this letter. After 18 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under FIFRA and is subject to review by the Agency. See FIFRA section 2(p)(2). If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) lists examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those claims approved through the registration process, FIFRA section 12(a)(1)(B). Therefore, should the Agency find or if it is brought to our attention that a website contains false or misleading statements or claims substantially differing from the EPA approved registration, the website will be referred to the EPA's Office of Enforcement and Assurance.

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

When this product is used as directed, it will control and inhibit the development of Chlorella Pyrenoidosa (Green), Phormidium Inundatum (Blackalgae), Phormidium Retzii (Square D Algae), Lyngba Versicolor (Blue-Green) and other swimming pool algae. This product is compatible with most commonly used swimming pool chemicals but should not be mixed with soap and other chemicals or premixed with other water-treating chemicals. This product works best when added by itself to pool water.

The appropriate amount of this product must be added by pouring directly into the pool along the edges while the filter and pump are in operation. To allow time for even distribution in pool water. Bathers must allow 10 minutes after treatment before entering the pool.

[INITIAL DOSE: Add [six][6] fl. Oz. of this product to 10,000 gallons of pool water.]

[MAINTENANCE DOSE: Add 1-1/2 fl. Oz. of this product to 10,000 gallons of pool water.]

[Initial dose is used when filling pool at beginning of swimming season. If pool has visible algae growth, the initial dose should be repeated within 48 hours after algae debris is removed from the pool. When pool is free of visible algae, use the recommended maintenance dose.[

[Maintenance dose should be added at least once every 7 days. If high temperatures prevail or pool has unusually heavy use, add maintenance dose more frequently. If makeup water is added the rate of more than 10% per week of pool capacity, add 1-1/2 ounces of this algaecide for each 10,000 gallons of fresh makeup water per week.]

[WINTERIZATION: When swimming season is over, add 6 fluid ounces of this product to 50,000 gallons of water in treating water left in pool. This dose helps provide a measure of control of algae growth during the winter months. This treatment will also help the servicing of the pool before it is resumed to use the following season.

{For Containers 1 gallon or less}

[STORAGE AND DISPOSAL

Keep container closed when not in use in an area inaccessible to persons unfamiliar with its use. Leaking or damaged containers should be placed in a plastic bag. Mop up spills with clean waer. NONREFILLABLE CONTAINER. Do not reuse container. Discard in trash or offer for recycling if available.]
