Window and door screens are best treated by applying the insecticide with a paint brush. Frequent spraying of breeding places such as stagnant water and garbage cans will help considerably in reducing the fly and mosquito population.

ANTS, FLEAS, ROACHES, SILVERFISH: Use twice the amount of insecticide recommended for flies and mosquitoes. Spray areas such as basement walls, floors, doorways where insects travel. Spray into cracks where they breed and hide. Spray sleeping quarters of pet animals bothered with fleas and change
