### **DIRECTIONS FOR USE** (continued)

#### **FLYING INSECTS**

PLIES, MOSQUITOES, GNATS: Direct the spray toward the upper portions of the enclosure and fill the atmosphere with mist, using 2 to 3 ounces of the product to each 1000 cubic feet of space. If passible, keep the doors and windows dosed for 10 minutes after applying the spray

#### CRAWUNG INSECTS

(Exposed or accessible stages)

ROACHES, SILVERFISH, SPIDERS: Spray infected areas thoroughly and direct the liquid behind baseboards, moldings, cabinats, shelves, sinks, door and window frames and pipes toward drains and dark corners, and into cracks, crevices, recesses and similar hiding places. Repeat as needed

ANTS: Treat shelves, cabinets and storage areas. Spray ant runs, trails, baseboards, thresholds and other places of entry, and treat nests liberally.

REAS, TICKS: Direct the spray toward lower wall portions, baseboards, rugs, carpets and floors of infested areas. Spray animal quarters, kennels and the bedding of pets and other domestic animals.

BEDBUGS: Apply liberally to top, ends, sides and bottom of mattresses, spraying oil tuths, seams and folds. Spray springs and frame, directing the liquid into all cracks, crevices and lock joints. Spray walls, baseboards, maldings, floors, closets and bedroom furniture with special attention to protected bedbug hiding and breeding places.

CLOTHES MOTHS and CARPET BEETLES: Remove infested articles from storage, brush thoroughly and, if possible, air several hours in direct sunlight. Apply spray liberally to all surfaces of empty chests, closets, bureous and storages, directing the liquid into crocks, joints and crevices. After airing, infested articles may be treated by holding the spray nozzle at least 3 feet away from the fabric and applying the liquid lightly to avoid the possibility of staining. Treat both sides of rugs, carpets and pads and all exposed and accessible surfaces of averstiffed furniture. Repeat application in 30 days for susceptible articles not stored in mothlight containers.

STORED FOOD PESTS (Exposed stages of flour beetles, weevils, cadelles, grain beetles, meal worms, meal moths, skippers, grain and cheese mites). To avoid smirces of reinfestation, wormy flour, grain and cereals should be destroyed before treatment. Spray thoroughly all surfaces of shelves, bins, cupboards, cabinets, pantries, lockers and similar storages, with special attention to cracks, niches, crevices and other hiding places.

### PRECAUTIONARY STATEMENTS HAZARDOUS TO HUMANS & DOMESTIC ANIMALS CAUTION
