Handle if equipped. Avoid breathing vapors or spray mist. Contains petroleum distillate. If swallowed do not induce vomiting. Get medical attention. Avoid contact with skin and eyes. In case of contact, immediately flush eyes or skin with plenty of water. Obtain medical attention if serious. Do not apply directly to food. Clean or remove all food processing surfaces thoroughly with soap and water with potable water all food processing surfaces before use. After spraying in manufacturing plants, bakeries and the food processing plants, wash and rinse with potable water all equipment, benches, shelving, etc. where required will be handled. Food processing equipment have to be stopped while applying a mist spray with care and in accordance with the directions and safety green signs. Do not use in rooms where white food is exposed. Remove pets, birds and other fish aquarium before spraying. Do not attempt to breathe spray and ventilate the area after treatment is completed.

ENVIRONMENTAL HAZARDS

This product is toxic to fish, birds and other wildlife. Do not apply directly to water. Do not contaminate water by cleaning of equipment or disposal of wastes. Apply the product only as specified on this label. Keep out of lakes, streams, or ponds. Do not apply where runoff is likely to occur.

PHYSICAL OR CHEMICAL HAZARDS

DO NOT spray into or near fire or open flames. DO NOT smoke while spraying. DO NOT use, pour, spill, or store near heat or open flames.

STORAGE AND DISPOSAL

STATEMENT OF PRACTICAL TREATMENT

If swallowed—Call a physician immediately. DO NOT INDUCE vomiting without the advice of a physician. Vomiting may cause aspiration pneumonia. If it is necessary to induce vomiting, give victim one or two glasses of water and insert finger in back of throat. Repeat until vomit fluid is clear. Do not induce vomiting or give anything by mouth to an unconscious person. If inhaled—Remove victim to fresh air. Apply respiration if indicated. If on skin—Wash immediately with soap and water. If in eyes—Flush eyes for at least 15 minutes with water. Call a physician immediately. See side/back panel for additional precautionary statements.

FLYING INSECTS

FLEAS, MOSQUITOES, GNATS: Direct the spray toward the upper portion of the enclosure and fill the atmosphere with mist, using 2 to 3 ounces of the product to each 1000 cubic feet of space. If possible, keep the doors and windows closed for 10 minutes after applying the spray.

**CRAWLING INSECTS
 (Exposed or accessible stages)**

ROACHES, SILVERFISH, SPIDERS: Spray infested areas thoroughly and direct the liquid into all baseboard moldings, cabinet, shelving units, door and window frames and joints, lamp shades and dark corners and into cracks, crevices, recesses and similar hiding places. Repeat as needed.

ANTS: Treat shelves, cabinets and storage areas. Spray ant nests, both baseboards, thresholds and other places of entry, and treat nests liberally.

BEES, TICKS: Direct the spray toward lower wall portions, baseboards, rug, carpets and floors of infested areas. Spray animal quarters, kennels and the bedding of pets and other domestic animals.

BEDBUGS: Apply liberally to top, ends, sides and bottom of mattresses, spraying all tufts, seams and folds. Spray springs and frame directing the liquid into all cracks, crevices and bed joints. Spray walls, baseboards, moldings, floors, closets and bedroom furniture with special attention to protected bedding, hiding and breeding places.

CLOTHES MOTHS and CARPET BEETLES: Remove infested articles from storage. Brush thoroughly and, if possible, air several hours in direct sunlight. Apply spray liberally to all surfaces of empty chests, closets, bureaus and storage, directing the liquid into cracks, joints and crevices. After airing, infested articles may be treated by holding the spray nozzle at least 3 feet away from the fabric and applying the liquid lightly to avoid the possibility of staining. Treat both sides of rug, carpets and pads and all exposed and accessible surfaces of upholstered furniture. Repeat application in 30 days for susceptible articles not stored in sunlight containers. For Carpet Beetles repeated liberal applications should be made to baseboards, corners and under furniture where these insects tend to congregate and cause damage.

STORED FOOD PESTS (Exposed stages of flour beetles, weevils, rodents, grain beetles, meal worms, meal moths, shipworm, grain and cheese moths): To avoid excess of infestation, remove flour, grain and cereals should be destroyed before treatment. Spray thoroughly all surfaces of shelves, bins, cupboards, cabinets, pantries, lockers and similar storages, with special attention to cracks, niches, crevices and other hiding places.
