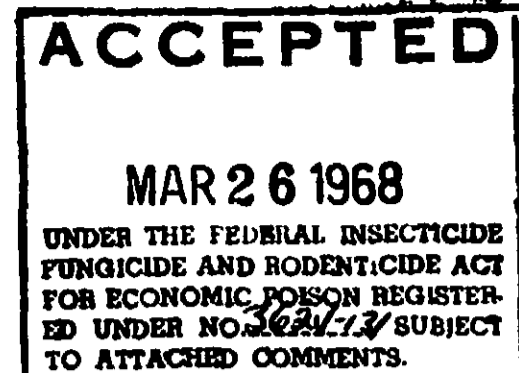

DIRECTIONS

DOSAGE: For initial treatment or for heavy infestations apply
at the rate of one gallon to 500 square feet. For subsequent
treatments use one gallon to approximately 1,000 square feet of
surface.

Meat Packing and Food Processing Plants: Apply as a coarse
spray or with a paint brush to walls, ceilings, and other
infested areas. Use only in the inedible products areas of
meat packing and poultry processing plants. Any exposed
food products, equipment or packaging materials must be removed
or covered before treatment. After treatment equipment and utensils
must be thoroughly rinsed with water before resuming operations.
Treat food processing plants early in the season before canning
or other processing begins. Repeat applications, if necessary,
when plant is not in operation.

Spraying unloading docks and outside areas where insects congregate will aid in preventing reinfestations. Good sanitation and proper disposal of wastes are essential in any effective insect control.

Inside Buildings:

Application should be made as a coarse spray or with a paint brush to baseboards, cracks, crevices, and other insect hiding places. Also apply to adjacent surfaces where insects will crawl when they come out of hiding. Heavy sprays may cause staining.

Exterior Use:

Apply as a coarse spray or with a paint brush to selected surfaces such as doors, screens, window frames, door sills, and areas of porches or patios where these insects alight or congregate. Apply to the nests of wasps after dark when all the insects have returned to the nest. Apply localized treatments to infestations of ants and fleas in outside areas where there is no vegetation. For ants, thoroughly wet hills and runways. Repeat as necessary to maintain control.

RESTRICTIONS

Do not use as a space spray. Avoid excessive wetting of asphalt tile, rubber, and plastic materials.

Do not spray on plants.

Do not spray in dairy barns or poultry houses.

Do not use in areas where children or pets come in contact with treated surfaces.

Remove fish or other pets from room before spraying.

WARNING.

May be fatal if swallowed, inhaled or absorbed through the skin. Rapidly absorbed through the skin. Do not get in eyes, on skin, or on clothing. Do not breathe spray mist. Wash thoroughly with soap and warm water after handling. Wash clothing in soap and hot water before reuse.

Avoid contamination of feed, food or food handling equipment.

If food handling equipment becomes contaminated, clean thoroughly before reuse. ~~KEE~~

ANTIDOTE: Administer atropine sulfate in large therapeutic doses. Repeat as necessary to the point of tolerance. 2-PAM is also antidotal and may be administered in conjunction with atropine.
