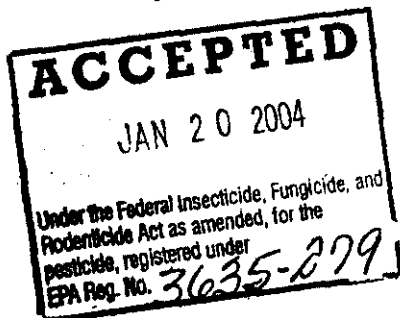

(FEATURES, CLAIMS & USES:)**

D'Germ is a disinfectant, bactericidal at 1:128 according to the AOAC Use-Dilution Test method, modified in the presence of 5% organic serum against: *Staphylococcus aureus* (Staph), *Pseudomonas aeruginosa* (*Pseudomonas*), and *Salmonella choleraesuis* (*Salmonella*).

**\*Official Virucidal Test**

D'Germ is virucidal against Herpes Simplex virus Type 2 (HSV-2) at 1:128 dilution on inanimate environmental surfaces.

D'Germ may be used on most metals (including aluminum and stainless steel) at 1 ounce per gallon of water. Rinse thoroughly. Septic tanks will not be affected.

**DIRECTIONS FOR USE:**

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

**For toilets** – It is not necessary to remove the water from the bowl. One (1) ounce is sufficient to remove soils, rust, lime, scale and uric acid deposits, and to disinfect and deodorize. Apply with special applicator or flip cap bottle. Open flip cap, invert bottle and with light pressure, direct stream of at least one (1) ounce completely around underneath side of toilet bowl rim. Wet bowl mop with solution and swab all surfaces above and below the waterline including seat and lid. Allow at least 10 minutes contact time for surface to be cleaned and disinfected. Rinse, repeat application for cleaning heavily encrusted deposits.

**On Solid Porcelain Urinals** – Place bowl mop over drain. Add enough water to make a solution and follow the same procedure as for toilet bowls. D'GERM will not damage solid porcelain china or vitreous ware.

**Shower Stalls** – Glazed tiles may be cleaned without damage. To clean and disinfect glazed ceramic tiles or other hard, non-porous surfaces, use one ounce in a gallon of water, allow 10 minutes contact time for surface to be cleaned and disinfected, rinse thoroughly.

To disinfect previously cleaned surfaces against *Trichophyton interdigitale* (Athlete's foot fungus), use 1-3/4 ounces in a gallon of water (1:73). Swab surfaces to be disinfected with this solution. Allow to remain in contact for 10 minutes, then rinse thoroughly.

*(For containers larger than one gallon)*

**STORAGE AND DISPOSAL**

Do not contaminate water, food, or feed by storage or disposal.

**PESTICIDE STORAGE:** Do not store near heat, sparks or open flame. Store in original container in areas inaccessible to children. Do not reuse empty container.
