DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

STORAGE AND DISPOSAL

Store in a cool area. DISPOSAL: Do not reuse empty container. Wrap and put in trash collection.

SPRAYER OPERATING INSTRUCTIONS:

1. Shake well before using.
2. Remove blue shipping cap and retain. Insert sprayer hose into bottle and tighten securely.
3. To operate sprayer, turn tip to "spray" or "stream". Do not operate when "off" is in the top position. Prime sprayer by holding at cap level and pumping trigger.
4. Nozzle should be 6-8 inches from surface being sprayed. Spray infested areas until wet.
5. Remove Sprayer and replace shipping cap between uses to prevent leakage, spillage, or evaporation. Spray water through sprayer after each use. Sprayer should be rinsed thoroughly and pumped empty for storage.

TO KILL Cockroaches, Ants, Waterbugs, Silverfish, Spiders, Crickets:
Spray heavily around baseboards, into all cracks and other places where these insects hide. Apply behind and under cabinets, refrigerators, sinks, plumbing fixtures, stoves and around waste containers. Spray directly on insects when possible. Repeat as necessary.

Ants: Follow the above instructions and also spray ant trails, and places where ants enter premises. Spray outdoor ant trails and runways.

TO KILL Brown Dog Ticks: Remove and destroy pets' old bedding. Spray sleeping quarters of pets, around baseboards, windows, door frames, walls and local areas of floors. Repeat as necessary. DO NOT SPRAY ANIMALS. Put fresh bedding in pets' quarters after spray has dried. Also treat dogs and cats with a registered tick product before allowing them to enter treated area.
