DIRECTIONS

ORB Aerosol Insecticide is essentially a contact insecticide and knocks down quickly and kills many flying insects enveloped in the spray mist, including flies, mosquitoes, gnats, flying moths. Wetting by direct spraying kills many crawling insects, including roaches, ants, silverfish and bedbugs.

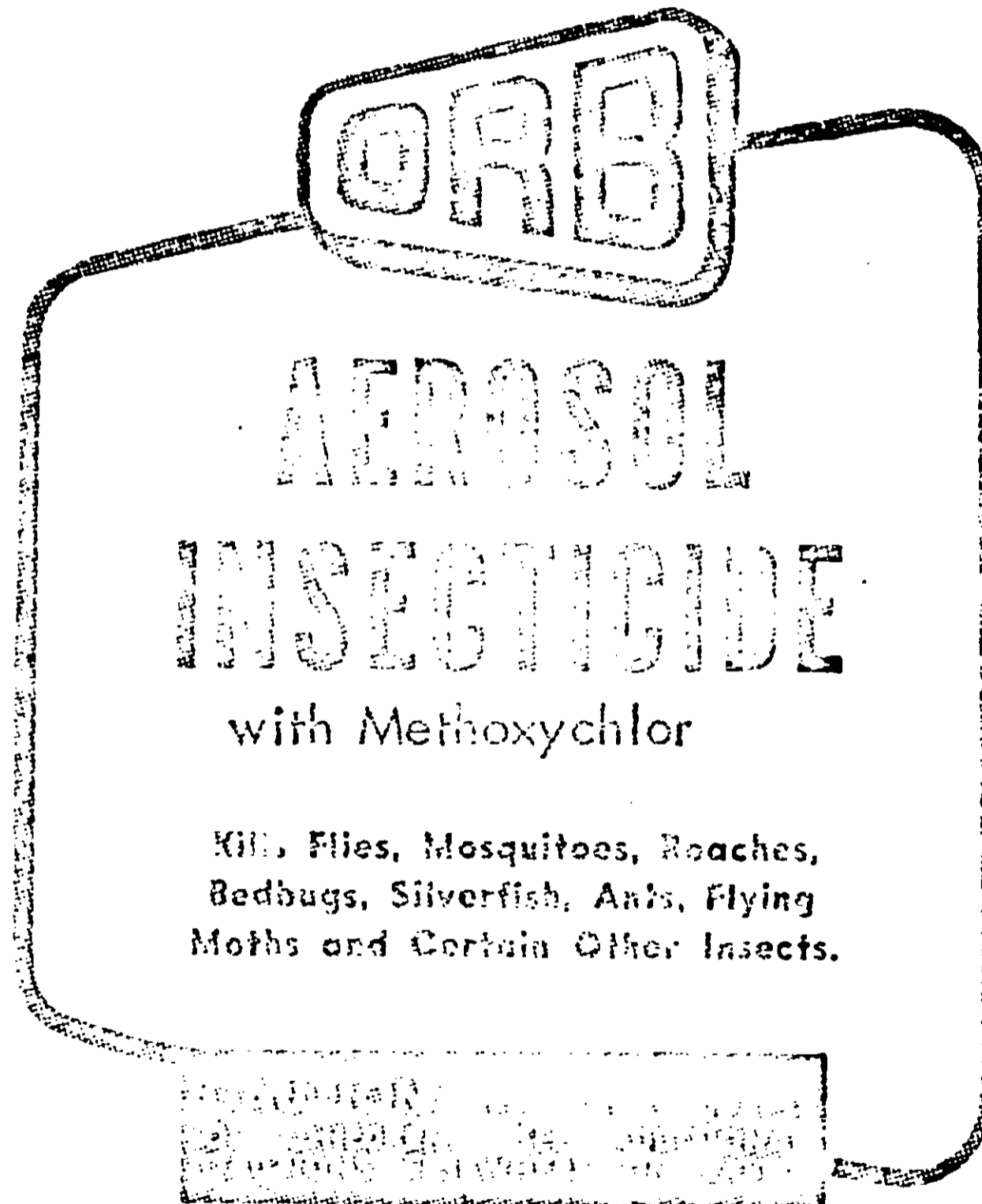
Flying Insects: Mosquitoes, flies, gnats, flying moths. Close doors and windows to confine spray. Spray upwards in all directions 4 to 5 seconds per thousand cubic feet. Keep room closed 15 to 20 minutes after spraying.

Crawling Insects: Roaches, ants, silverfish. Spray insects directly and spray into hiding places. Spray into cracks and crevices under and behind sinks, cupboards, drawers, woodwork, refrigerators, pipes and drains where insects occur. Spray insects directly when driven out of hiding by spray. Keep room closed for 30 minutes after spraying. Repeat as necessary.

Moth Worms and Carpet Beetles: Clean and spray closet thoroughly to reach all hiding places. Clean and brush articles to be protected and then holding Aerosol 24 inches from article, spray thoroughly, but not heavily enough to wet fabric. Give particular attention to seams and folds. Allow articles to dry completely before storing or using. Repeat application every 30 days unless articles are stored in airtight containers previously cleaned and sprayed with ORB Aerosol Insecticide.

Bedbugs: Take bed and other furniture apart and spray thoroughly, slats, springs, and all cracks and crevices. Spray thoroughly entire mattress, especially seams and tufts and allow to dry completely before using. Spray all cracks and hiding places in room, including behind woodwork, loose wallpaper, picture frames and molding. Repeat applications as necessary.

Outdoor Use: To temporarily repel many annoying insects on porch, terrace, lawn and at outdoor gatherings, spray frequently around chairs, tables, and in the immediate vicinity.

CAUTION

Contents of this can are under pressure. Do not store near heat, in direct rays of sun, in closed cars in the sun or in any other location where temperatures will exceed 110 deg. F. If exposed to high temperatures excessive pressure will develop and may cause can to burst as with any Aerosol bomb. Do not puncture or incinerate can.

Keep out of reach of children. Avoid contamination of foodstuffs. Do not use on humans, pets or plants. Remove bird cages and fish bowls from room before spraying. Avoid prolonged inhalation of spray by leaving room after use and keep people at least two feet from surface to avoid staining.
