DIRECTIONS FOR USE

This aerosol product is designed for use indoors, such as attics and other places where nests are built, or outdoors. It will kill Wasps, Hornets, Yellow Jackets, and Bees. It will shoot a 10 foot stream.

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

FOR CONTROL OF WASPS, HORNETS, YELLOW JACKETS AND BEES: Aim spout/nozzle at the nest, crevice or hole where infestation or insects are known to be inside and depress the button. Continue to spray until the nest is soaked with the insecticide. Repeat as necessary. It is preferable to apply this product after dark when all the insects have returned to the nest. When using this product, always try to keep the wind at your back.

STORAGE AND DISPOSAL

STORAGE: Store upright in a cool, dry area away from heat or open flame. Keep out of reach of children. If container is damaged and leaking, allow contents to dissipate out of doors. DISPOSAL: Do not reuse empty container. Replace cap and wrap container and discard in trash. Do not incinerate or puncture. Do not contaminate water, food or feed by storage or disposal.
