DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

SBAKE WELL BEFORE USE

TO KILL FLYING INSECTS: Cluster Flies, Flies, Fruit Flies, Gnat, Horn Flies, House Flies, Mosquitoes, Small Flying Moths, Stable Flies, and Wasps. Close all windows and doors and spray upward into the center of the room with a slow, sweeping motion. Spray 5 to 10 seconds for the average room (1,000 cu. ft.). Keep nozzle three feet from surfaces. Keep room closed for 15 minutes after spraying. Ventilate room thoroughly before reentry. Repeat treatment as necessary.

TO KILL CRAWLING INSECTS: Ants, Beetles, Booklice, Centipedes, Clover Mites, Crickets, Millipedes, Roaches, Silverfish, Sow Bugs, Spiders, and Waterbugs. Spray baseboards, cracks, crevices, moist areas, and openings around sinks and pipes and other hiding places, hitting the insects directly. Spray ant hills and ant trails, over window and doorsills and other locations. For general volumetric treatment, close doors and windows. Open cabinets and drawers. Spray upward into the center of the room in a slow, sweeping motion at a rate of 20 seconds per 1,000 cu. ft. of space. Keep area closed for 15 minutes. Ventilate area thoroughly before reentry. Repeat treatment as necessary.

To treat Mud Dauber and Wasp nests, spray directly onto nests and insects from a distance of two (2) feet. Apply late at night when insects are inactive.

To kill Carpet Beetles, Confused Flour Beetles, Cigarette Beetles, Drug Store Beetles, Grain Mites in exposed adult and larvae stages, Granary Weevils, Red Flour Beetles, Rice Weevils, and Sawtooth Grain Beetles, spray cracks and crevices, around cartons and containers and other areas where insects congregate. Direct spray at insects which are visible. For general volumetric treatment, spray at a rate of 20 seconds per 1,000 cu. ft. of space. Keep area closed for 15 minutes. Ventilate thoroughly before reentry. Repeat treatment as necessary.

To kill Anguomois Grain Moths, Chocolate Moths, Indian Meal Moths, Mediterranean Flour Moths, close all windows and doors and spray all parts of the room at a rate of 5 to 10 seconds per 1,000 cu. ft. of space. Keep area closed for 15 minutes. Ventilate thoroughly before reentry. Repeat treatment as necessary.

To kill fleas: While holding can three (3) feet above floor, spray floor and lower walls at a rate of 10 seconds per 1,000 sq. ft. of area. All floor, sofa, and chair surfaces must be contacted with the spray. Keep area closed for 15 minutes. Ventilate thoroughly before reentry. Repeat treatment as necessary.

SEST AVAILABLE COPY

To kill Flies, Gnats, and Mosquitoes in outdoor areas such as campgrounds, spray in a wide sweeping motion at a rate of 60 to 80 seconds per acre of area. Application should be made when wind speed is 5 mph or less. Repeat treatment as necessary.

STORAGE AND DISPOSAL

Storage: Store upright in a cool, dry area away from heat, sparks, and

open flames. Keep out of reach of children. If container is

leaking, allow contents to dissipate out of doors.

Disposal: Replace cap, wrap container in several layers of newspaper and

discard in trash. Do not incinerate or puncture.

PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS AND DOMESTIC ANIMALS

CAUTION: Harmful if swallowed or absorbed through skin. Do not breath vapors or spray mist. Do not remain in an area which has been treated and ventilate area before reentry. Avoid contact with skin and eyes. In case of contact, flush with plenty of water. Wash with soap and water after use. Obtain medical attention if irritation persists. Avoid contamination of water, food, or feedstuffs. Remove all pets and birds. Cover fish tanks or remove before spraying.

Do not apply while food processing is underway. Cover or remove all food processing surfaces. Thoroughly wash all food processing surfaces before reuse. After spraying in baleries, meat packing plants, food processing plants, etc., all benches, shelving, equipment, etc. where exposed food will be handled must be washed with an effective cleaning compound followed by a potable water rise to remove all traces of contamination.
