

DIRECTIONS FOR USE

SEED TREATMENT: A special powder formulation for treatment of corn and soybean seed, prior to planting, for the temporary protection of germinating seeds and seedlings against seed and soil-borne diseases, including damping-off, seed decay organisms, and seedling blights.

PLANTER BOX APPLICATION: Prepared for use directly in the planter box, or may be mixed in any commercial seed treater, barrel treater, or rotating container, such as a cement mixer. Best protection will be obtained where every seed is coated with the chemical. **DO NOT USE TREATED SEED FOR FOOD, FEED OR OIL PURPOSE.**

KEEP PLANTER PLATES CLEAN: Grease or oil on plates can cause clogging.

***NOTE:** Captan 50 Seed Protectant has been mixed with graphite as an aid in safe handling and lubrication of equipment.
