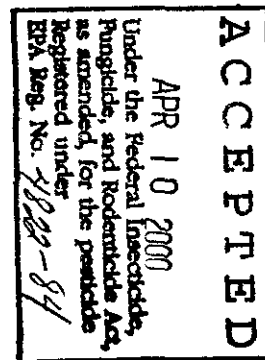

**FOR USE IN AND AROUND:** Apartments, Homes, Hospitals, Hotels, Food Storage Areas, Inedible Products Areas of Meat Packing Plants, Food Processing Plants, Motels, Nursing Homes, Restaurants and Other Food Handling Establishments, Supermarkets, Transportation Equipment (Buses, Boats, Ships, Trains and Planes†), Warehouses and Other Commercial and Industrial Buildings.

**DIRECTIONS FOR USE:**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. Do not apply this product in a way that will contact any person or pet, either directly or indirectly. Keep people and pets out of the area during application.

Apply to surfaces as a spot treatment only. Do not spray up into air. Point spray opening toward surface to be sprayed and press button firmly. Spray around baseboards, into cracks and crevices, around doors, windowsills and plumbing and other places where insects may enter. Spray in inaccessible areas behind and beneath sinks, stoves, cabinets, refrigerators, damp areas and in and around waste containers. Hold about 12" from the surface being sprayed. Spray until surfaces appear wet. Avoid excessive wetting of asphalt, tile, rubber, and plastic. Do not spray open floor areas, furniture, beds or bedding. Clean any exposed area where food or people may contact.

**ENTRY RESTRICTIONS:** Do not allow people or pets to enter the treated area until sprays have dried.

**ANTS:** Apply to ant trails, around doors, windows, and wherever ants enter house. Do not treat entire area of floor, or floor covering. Repeat as necessary.

**ROACHES, WATERBUGS.** Spray until wet in cracks, around baseboards and other hiding places. When bugs are driven out, spray directly. Repeat as necessary.

**SILVERFISH, CRICKETS, SPIDERS:** Spray infested areas as recommended under directions for use. Repeat as necessary.

**APPLICATIONS IN FOOD HANDLING ESTABLISHMENTS:** Food Handling Establishments are places other than private residences in which food is held, process, prepared or served.

**FOOD AREAS - APPLICATION LIMITED TO CRACK AND CREVICE® TREATMENT ONLY:**

Includes areas for receiving, storage, packaging (canning, bottling, wrapping, boxing), preparing, edible waste storage and enclosed processing systems (mills, dairies, edible oils, syrups). Serving areas (when food is exposed and facility is in operation) is also considered a food area.

Apply prescribed amounts of Bolt Ant & Roach Killer as a Crack & Crevice® application using the supplied injection tube [or brandname equipment] in points between different elements of construction, between equipment and floor, openings leading to voids and hollow spaces in walls, equipment legs and bases where insects hide.

Care should be taken to avoid depositing the product onto exposed surfaces or introducing the material into the air. Avoid contamination of food, food utensils or food processing surfaces.

**PRECAUTIONARY STATEMENTS  
HAZARDS TO HUMANS AND DOMESTIC ANIMALS**

**CAUTION.** Harmful if swallowed, inhaled or absorbed through skin. Causes moderate eye irritation. Avoid contact with skin, eyes or clothing. Avoid beaching spray mist. Remove contaminated clothing and wash clothing before reuse. Wash thoroughly with soap and water after handling. Do not smoke while using. Provide adequate ventilation of area being treated. Do not apply to humans, pets or plants or contaminate, feed, foodstuffs, dishes or utensils. Cover and avoid spraying fish aquariums. **USER SAFETY RECOMMENDATIONS**
