

DIRECTIONS

Carmel Residual Insecticide is to be brushed or sprayed on surface locations such as floors, walls, window sills, screens to leave an invisible stable residue after evaporation which acts as a nerve poison to kill flying and crawling insects which congregate on the sprayed surface.

For use in food processing plants for killing exposed stages of Roaches, Waterbugs, Silverfish, Flour and Grain Beetles, and Weevils. To kill houseflies, thoroughly wet all areas where these insects alight or congregate.

Application should be made at rate of 1 gallon per 500 square feet of unpainted wooden surfaces, concrete, brick and masonry. For treating painted wood, metal and glass, use at rate of 1 gallon per 1000 square feet of surface. Use as a coarse wet spray to treat all surfaces, cracks and crevices of infested areas until wet.

For Bakeries, Flour Mills, and other Food Processing Plants: Use as a coarse, wet spray to treat surfaces, cracks and crevices of infested areas until wet. In storage warehouses, spray the floors and walls whenever stock is moved. Repeat treatments as often as necessary.

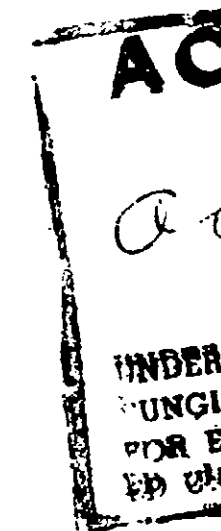

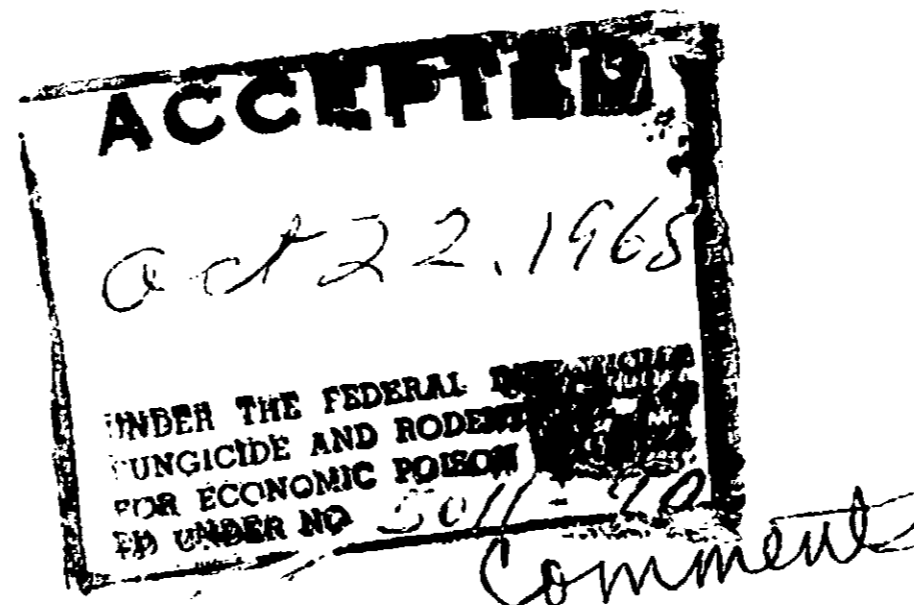
