

GENERAL INFORMATION:

Old Fox Daconil 2.5 G fungicide is highly effective and widely recommended for the control of a number of important lawn diseases. For proper turf maintenance, Daconil 2.5 G should be applied before diseases are expected to appear.

Daconil 2.5 G is formulated for use on lawns, parks, grass tennis courts and other fine turf areas.

DIRECTIONS FOR USE:

Lawn and turf-for disease prevention and/or curative measures on moderate disease infestations on any of the following:

Helminthosporium

leaf spot and melting out Curvularia leaf spot

Dollar Spot
Brown patch
Green leaf spot

Green leaf spot
Stem rust of bluegrass
(Helminthosporium spp.)

Copper spot (Curvularia spp.) (Sclerotinia homoeocarpa)

(Rhizoctonia solani)
(Piricularia grisea)
(Puccinia graminis)
(Gloeoeercospora sorghi)

Apply 8 pounds of this material on 1,000 square feet (25' x 40') of damp lawn. For best results, apply following a light rain or water lawn before application. Do not mow or water grass after treatment, wait until the grass is thoroughly dry. A 24-hour waiting period is preferred. Do not graze or feed clippings to live stock. Repeated applications should be made on 7-14 day intervals.

Lawn and turf-for curative treatment of severe disease conditions for any of the above diseases, apply 16 pounds of this material on 1,000 square feet (25' x 40') on damp lawn. Depending on the severity of the disease, additional applications may be necessary on a seven-day schedule.
