

PRECAUTIONARY STATEMENTS
HAZARDS TO HUMANS AND DOMESTIC ANIMALS

CAUTION

APPLICATION INSTRUCTIONS

PAINTS AND STAINS: Use 0.2-1.0%.
WOOD PROTECTIVE STAIN: Use 0.3-1.25%.
ADHESIVES, CAULKS, GROUTS AND SEALANTS: Use 0.2-0.8%.
STUCCO: Use 0.1-0.8%.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.
PESTICIDE STORAGE: Storage temperatures below 90°F (32° C) and above 32°F (0°C) are suggested.
