Dear Ms. Rahn:

The amended labeling referred to above, submitted in connection with registration under the Federal Insecticide Fungicide and Rodenticide Act (FIFRA), as amended which adds pomr fruit, group 11-10, sweet cherries, olives oranges, tangerines and rambutan acceptable provided that you make the following labeling changes:

You must revise "Pome fruit (EPA Group 11)" to "fruit, pome, Group 11-10".

As a condition of registration you must submit the following study by June 1, 2014:

-Immunotoxicity study is required as part of the new 40 CFR Part 158 requirements for registration of a pesticide.

Submit one copy of your final printed labeling before you release the product for shipment.
