TOBACCO PLAR? BED: For control of Blue Mold, Anthracnose, Flea Beetle, Midge and Crane Fly Larva, and Aphids—use 1 to 2 poulpts Der 100 square yards depending on the size of the plants. Make first application when the leaves are the size of a dime. Continue holds weeks: thereafter. Do not apply within 5 days of pulling. Repeat any application washed off by rain/within 24hours.If insects the holds are seen use. 15% Fermate as recommended on the label for control of Blue Mold and Anthracnose.
