DIRECTIONS FOR USE

It is a violation of Federal laws to use this product in a manner inconsistent with its labelling.

For outdoor use. Can also be used in attics, warehouses, and other storage areas where foods and feedstuff are not exposed.

For Outdoor Use: Application should be made in late evening when insects are at rest. Hold can upright. Remove cap. Point valve opening away from face. With wind at back, aim at nests in trees, bushes, under eaves, chimneys, cracks or crevices. For Indoor Use: Point valve opening away from face. Aim directly at nests under rafters, etc. Do not spray in areas where foods and feedstuffs are exposed or handled.

Thoroughly saturate nests with spray, contacting as many insects as possible. To prevent insects from falling on skin and clothes, do not stand directly under nest. Best results can be obtained if nest is sprayed in late evening when most insects are at rest. If reinfestation occurs, repeat treatment.

STORAGE AND DISPOSAL

STORAGE: Do not store at temperatures above 130°F.

DISPOSAL: Do not incinerate. Do not reuse empty container. Wrap container and put in trash collection.
